


**Upon motion of Dr. Thomas Campanella, seconded by Mr. Dave Pavlock, the Board unanimously approves the request to sublease to Rob Babcock d/b/a The Plunge to operate a portable waterslide concession on leasehold property at 165-A Fort Pickens Road for one (1) year with the following conditions: placement of two (2) port-a-lets one of them handicap accessible, a minimum of four (4) employees at a time one (1) must be CPR certified, access to the slide from the Casino parking lot/Gulf side only, 24 hour security, deflate each night and inflate each morning, generator power, water from tanks, seasonal operation seven (7) days a week, signage on the Pensacola Beach Gulf Pier with a directional arrow, and subject to all applicable codes and regulations.
