1-3. A Special Board Meeting of the Santa Rosa Island Authority was held on Monday, June 23, 2010, beginning at 5:07 PM. Members in attendance were: Dr. Thomas Campanella, Mr. Vernon Prather, Mr. Ed Guernsey and Mr. Fred Gant; Ms. Tammy Bohannon, Chairwoman, and Mr. Dave Pavlock were absent. Mr. Guernsey called the meeting to order and led the Pledge of Allegiance followed by a moment of meditation.

4. ADOPTION OF AGENDA

5. CHAIRWOMAN'S COMMENTS - Executive Director Buck Lee gave an update in Ms. Bohannon's absence. Mr. Lee explained that today we were hit hard with what we had been dreading; the oil has reached our beach. Beginning at Avenida 10 and getting worse the farther west you go. Governor Crist was here this morning and met with officials from the Coast Guard and others to assess the damage. At 12:20 PM an advisory was issued to stay out of the water on the Gulf side however; the sound side is still open for swimming. We are trying everything we can to find the best and most efficient way to get our beach back and expect to have equipment by tomorrow to begin the difficult clean-up process.


