Administrative and Operational Issues

FEMA Flood Mitigation Assistance Program Grant

On November 14, 2022, SRIA submitted an application for the Flood Mitigation Assistance (FMA) grant program. The submittal was a culmination of work that began with the February 17th community meeting and hours of data collection and work by the subconsultant with the assistance of the interested leaseholders. Of the original twenty-eight leaseholders that expressed interest, ten ultimately wished to continue and submitted the necessary documentation to do so. The total grant request was just over \$3.3 million dollars. The State now reviews all grant applications submitted and has until late January to submit the state-wide request to FEMA. The grant awards will be announced sometime in 2023 after FEMA has reviewed and notified the states accordingly.

Little Sabine/Lafitte Cove Dredging and Baby Beach Nourishment - Information Meeting

Little Sabine and Lafitte Cove are both due for maintenance dredging. Sand obtained from Little Sabine and Lafitte Cove maintenance projects typically meets the criteria for nourishment projects along Santa Rosa Sound. Sand obtained from the currently required maintenance dredge is expected to be utilized for a nourishment project at Baby Beach. Additionally, Baby Beach has experienced repeated upland erosion issues that need mitigating. As such, SRIA, through BDI, has been working to develop and design a comprehensive dredging/nourishment/erosion control project. The Board allocated funding in the FY23 budget for all three projects. The necessary permits for those projects have now been obtained, and the project will soon go out to bid.

On behalf of SRIA, BDI will be conducting an informational meeting providing specifics on the project to beach residents and other interested parties.

Economic Impact of Pensacola Beach

Tourist Development Tax Collections (Attachments 1 and 2 – October 13, 2022, report and the November 4, 2022, report as prepared by Pam Childers, Escambia County Clerk of Circuit Court and Comptroller)

The Tourist Development Tax (TDT) is a tax rate applied to transient rental transactions. In Escambia County the rate is 5% on the total payment received for the rental or lease of living quarters and accommodations (i.e. apartment, condominium, hotel/motel, mobile home or RV park, single-family home, etc.) that are rented for a period of six months or less.

The tax proceeds are statutorily limited in terms of use. In general, proceeds may be used for capital construction of tourist-related facilities, tourist promotion, and beach and shoreline maintenance; however, the authorized uses vary according to the particular levy. The Tourist Development Council (TDC) reviews proposals for the expenditure of funds to determine whether the expenditure complies with the tourist development plan of the ordinance and makes recommendations to the Board of County Commissioners for use of the funds.

- **Gulf side pavilion repairs** – Stucco repairs, truss plate replacements, and painting. Complete.
- **Little Sabine Pump** – County staff is preparing an item to take to the Escambia County Board of County Commissioners to authorize the re-installation of the Little Sabine pump. It is anticipated that the item will appear on the December 3, 2022, BOCC agenda.
- **Dune walkover 27C** – The topographic survey is in progress now. BDI indicates that the preliminary design and plans should be complete by mid-December. Once reviewed by SRIA staff, plans will be forwarded to the County for award of contract and construction.
- **Pensacola Beach Fish Sign** – The BOCC has awarded the bid. The exact timeline for installation of the new sign has not yet been established.

SUBJECT: Tourist Development Tax (TDT) Collections

RECOMMENDATION:

That the Board accepts, for filing with the Board's Minutes, the Tourist Development Tax (TDT) Collections Data for the August 2022 returns received in the month of September 2022, as prepared by the Treasury Department of the Clerk and Comptroller's Office.

- Total collections received in September 2022 were \$1,936,141 compared to \$2,107,614 in September 2021. A comparison of September 2022 to September 2021 is a 8% decrease.
- Year-to-date collections for FY2022 is \$21,825,936 compared to \$17,658,986 for FY2021.

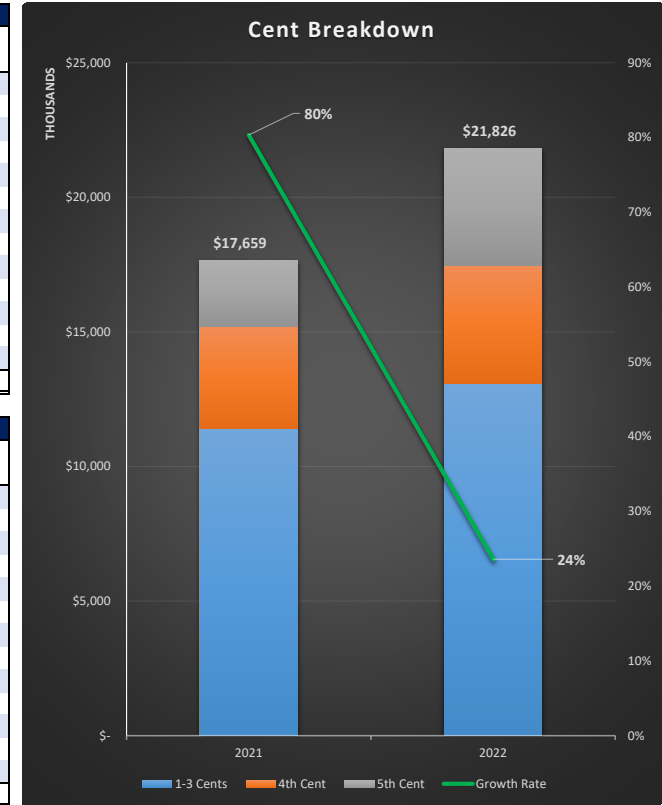

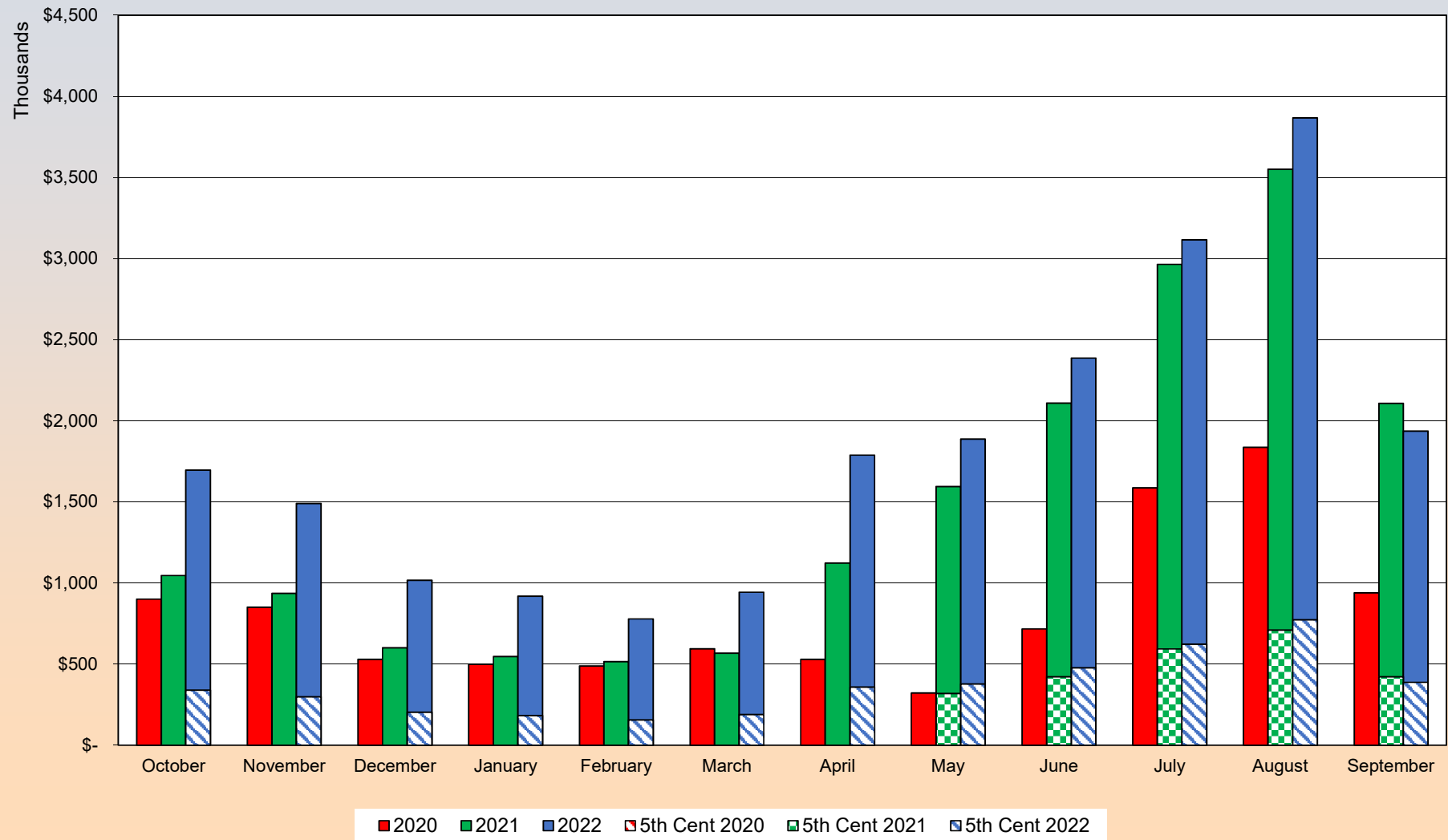

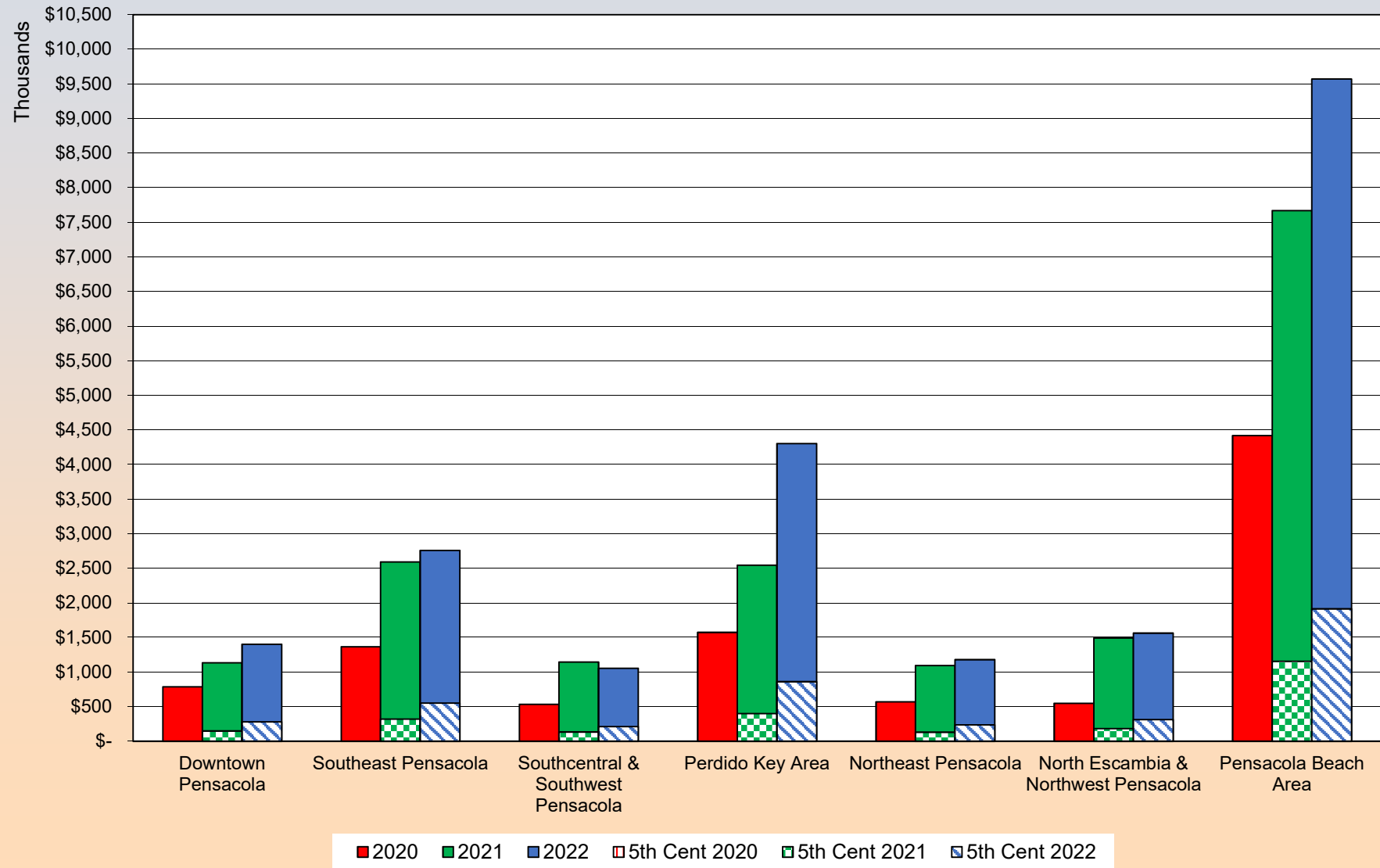

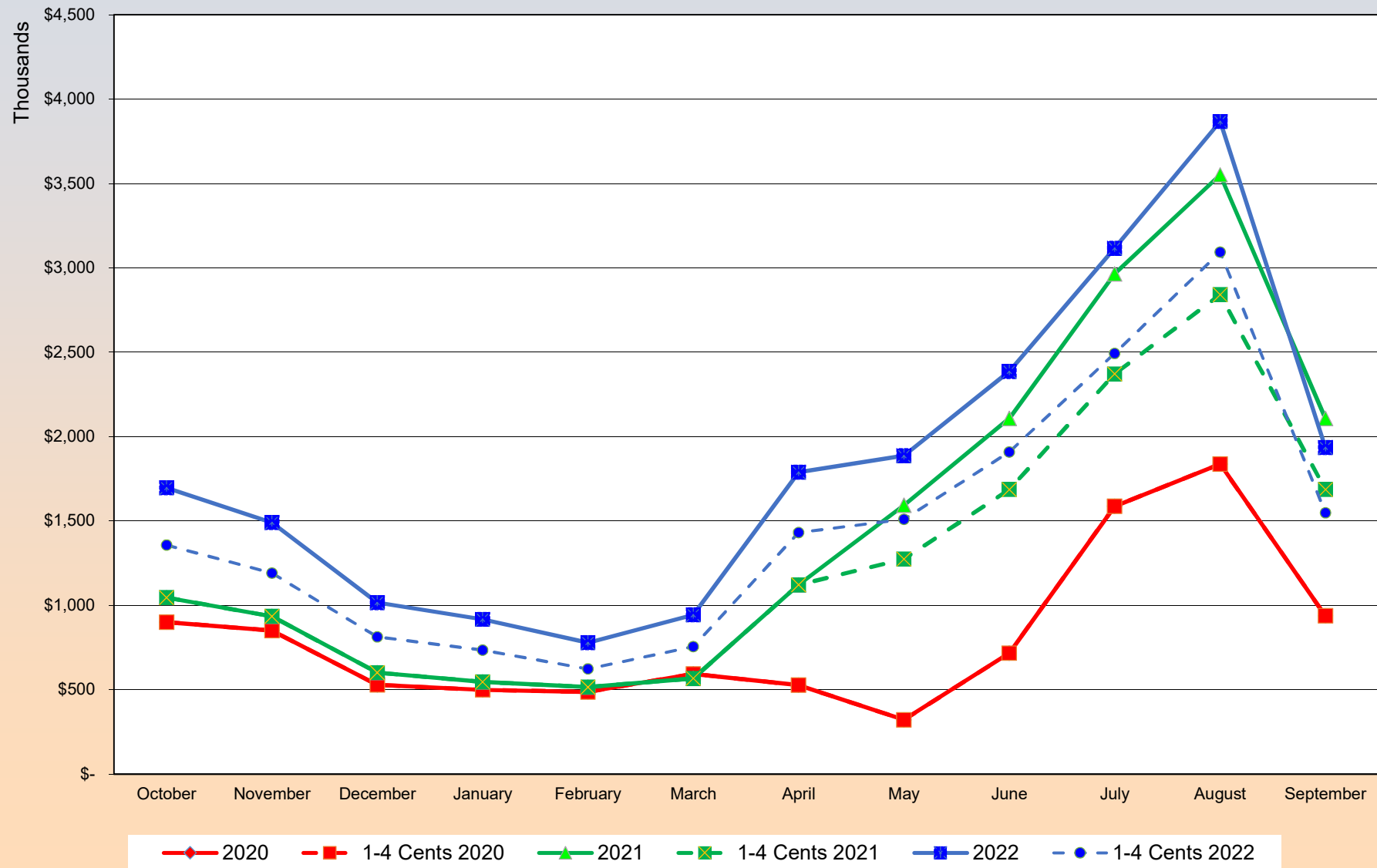
Tourist Development Tax Collections

Returns through August 2022 (Collected in September 2022)



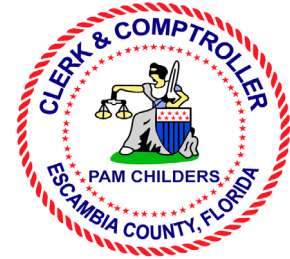

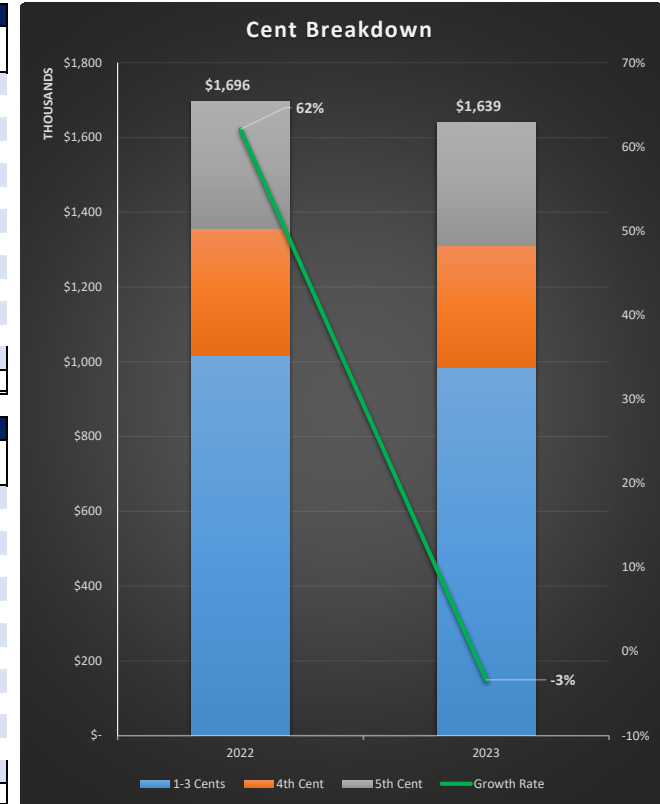

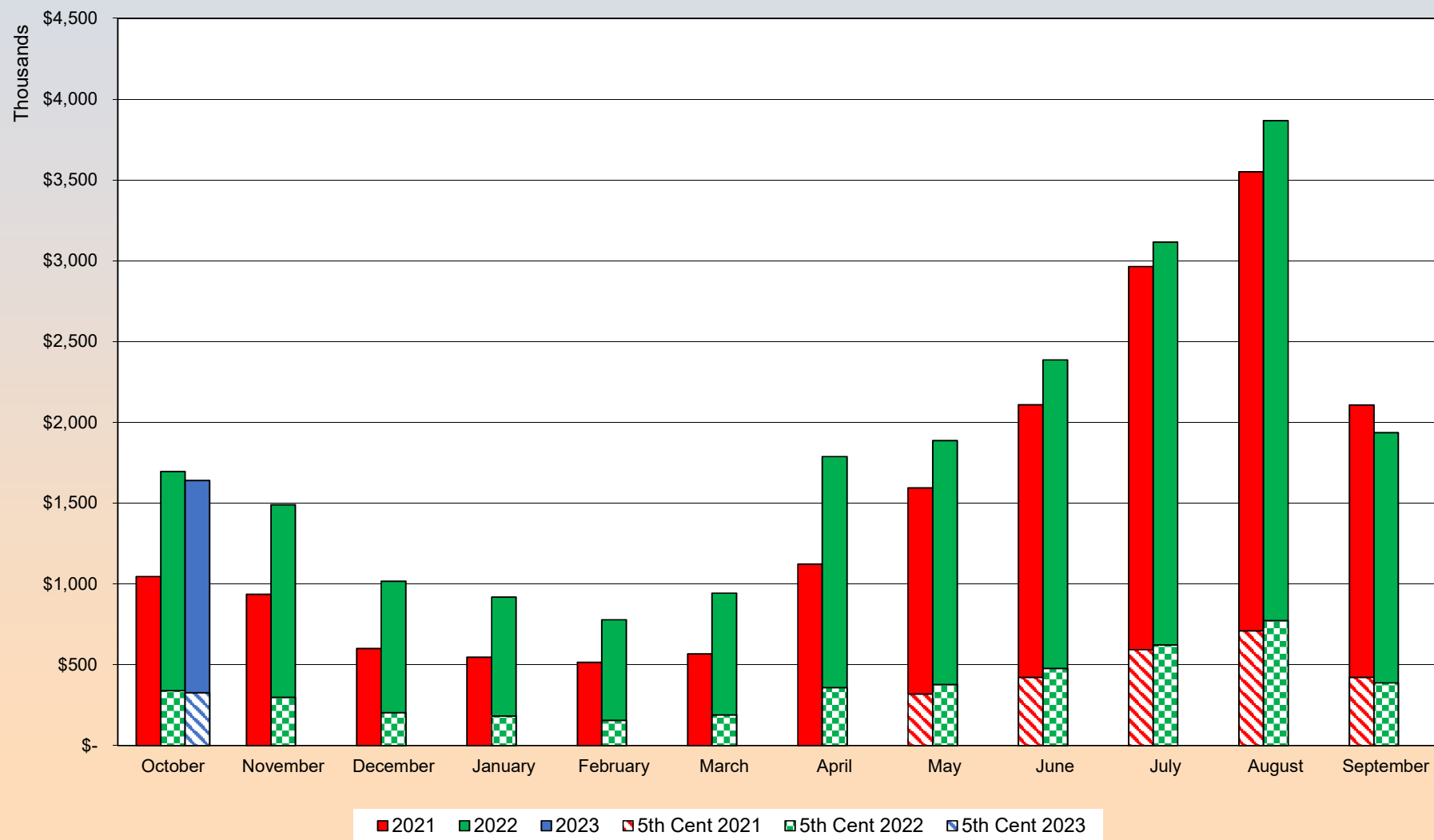

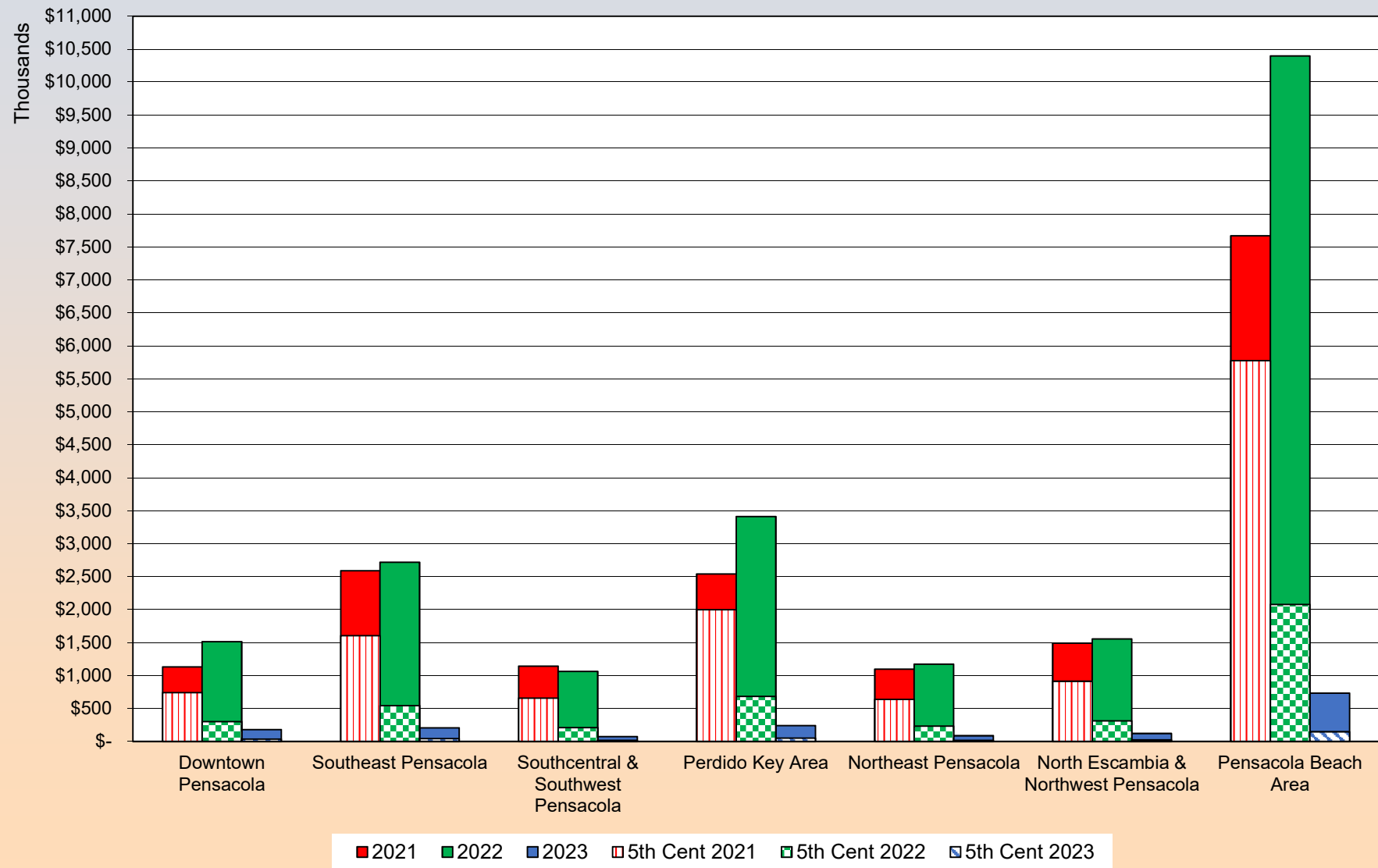
