Staff Development

Promoting organizational, hurricane preparedness and response, staff were required to complete the basic Inci dent Command System (ICS) trainings, ICS 100 and ICS 700. As of May 16, 2022, all SRIA employees have completed the two courses. In addition to the two introductory courses, all Director-level team members have completed ICS 200, ICS 300, IS 800 and IS 2200 designed specifically for Division/Group supervisors or director-type positions.

Director of Development Services, Juan Lemos, attended the Association of State Floodplain Managers national conference May 15-19, in Orlando. Attendance afforded Mr. Lemos the opportunity to earn continuing education credits towards his Certified Floodplain Manager designation, meet with FEMA representatives, and network with other floodplain managers from around the country. It was a unique opportunity to have the national conference so close in proximity.

Assistant Manager of Administration, Kara Gauntt, graduated the from the Leadership Pensacola (LeaP) program, class of 2022, on May 23. The program, which took 22 months to complete due to COVID interruptions, helps participants acquire an in-depth, balanced understanding of issues, problems and opportunities facing the greater-Pensacola area and gain the leadership skills necessary to resolve them. It creates a synergistic environment to enhance leadership skills, thereby providing a common ground for working together on community needs.

Staffing

The Administrative Clerk vacancy within the Department of Development Services was advertised on April 28, and applications were accepted through May 20. The response was good with 37

SUBJECT: Tourist Development Tax (TDT) Collections

RECOMMENDATION:

That the Board accepts, for filing with the Board's Minutes, the Tourist Development Tax (TDT) Collections Data for the March 2022 returns received in the month of April 2022, as prepared by the Treasury Department of the Clerk and Comptroller's Office.

- Total collections received in April 2022 were \$1,788,724 compared to \$1,122,039 in April 2021. A four percent comparison of April 2022 to April 2021 is a 28% increase.
- Year-to-date collections for FY2022 is \$8,632,890 compared to \$5,334,146 for FY2021.


