Operational Improvements

Status of Requests for Qualifications (RFQ) Solicitations

Per SRIA Board direction, Requests for Qualifications will soon be released for Coastal Engineering Services and General Engineering Services. Notice of solicitation will be advertised in the Pensacola News Journal, on the Florida Engineering Society website, and the SRIA website (under the new Legal Ads tab).

Additionally, in the spirit of continuous improvement and cost management, the Santa Rosa Island Authority will now be utilizing BidNet Direct to post Requests for Proposals (RFP), Requests for Qualifications (RFQ), and other bid opportunities at no cost to the Authority. Several local jurisdictions within the geographical area currently utilize this system including: Emerald Coast Utilities Authority (ECUA), Escambia County School District, City of Pensacola, City of Milton, University of West Florida, City of Mary Esther and others.

BidNet Direct allows for numerous vendors across the state who are registered with BidNet to access the full RFQ and elect to receive notifications regarding updates or addenda. It also allows SRIA staff to send notices directly to designated vendors whether they are registered vendors with the BidNet system or not. The platform allows for better administration and management of the overall purchasing and bid process and a way to reach vendors that might otherwise not be unaware. Economic Impact of Pensacola Beach

<u>Tourist Development Tax Collections</u> (Attachment 1 – Full January 7, 2022, report as prepared by Pam Childers, Escambia County Clerk of Circuit Court and Comptroller)

The Tourist Development Tax (TDT) is a tax rate applied to transient rental transactions. In Escambia County the rate is 5% on the total payment received for the rental or lease of living quarters and accommodations (i.e. apartment, condominium, hotel/motel, mobile home or RV park, single-family home, etc.) that are rented for a period of six months or less.

The tax proceeds are statutorily limited in terms of use. In general, proceeds may be used for capital construction of tourist-related facilities, tourist promotion, and beach and shoreline maintenance; however, the authorized uses vary according to the particular levy. The Tourist Development Council (TDC) reviews proposals for the expenditure of funds to determine whether the expenditure complies with the tourist development plan of the ordinance and makes recommendations to the Board of County Commissioners for use of the funds.

In the first quarter of FY22, Pensacola Beach Area accounted for 40.8% of all collections received in the County. The second highest area of collections was the Perdido Key Area bringing in 16.7% of the collections' total.

Blue Angels Homecoming Air Show Economic Impact (Full report was distributed to the SRIA Board electronically on 12/16/22). *Excerpts are provided below.

Total economic impact is a function of direct spending by visitors in the Pensacola area, as well as the indirect and induced effects of this spending, such as increased business and household spending generated by tourism dollars.

- The Blue Angels Homecoming Air Show 2021 attracted 64,200 unique attendees, 34,400 out-of-county attendees and 29,800 locals
- > 54% of attendees were out-of-county visitors
- Out-of-county visitors spent \$7,763,900 in the Pensacola area during the event (November 5-6, 2021). Spending includes accommodations, restaurants, groceries, transportation, attractions, entertainment, tickets, shopping, and "other" expenses.
- Total economic impact generated by out-of-county visitors was \$11,645,850 in the Pensacola area

Specific to SRIA, as reported by Ms. Johnson at the January Committee meeting, the Blue Angels Homecoming Air Show contributed to an 130.6% increase in November revenues over that of 2020. That equates to nearly \$134,000 increase in collections over 2020 (exactly \$133,935).

Beach Projects Update

- <u>Crosswalks</u> This project was approved by the SRIA Board on November 10, 2021. The Interlocal
 Agreement with the County to manage the project was approved on January 6, 2022. On-site preconstruction meeting was held with the contractor, Escambia County project manager, and SRIA
 staff on January 26. Construction of the crosswalks are anticipated to be complete by March.
- <u>Hurricane Sally Repairs</u> This project, in part, includes: repairs to Park East and Park West restrooms, repairs to pavilions at Park West and Quietwater Beach, and walkovers at Park West. The project is already out to bid. A pre-solicitation meeting was held on 1/26 and a site walk-through is scheduled for 1/27. The bid opening is scheduled 2/3/22.

- <u>Lafitte Cove Dredging</u> The bid award was approved by the BOCC on January 18. Scheduling is currently being coordinated with the contractor through Escambia County's Natural Resources Management Department.
- Morgan Park Renovations A new deck has been constructed, new trail borders have been installed, weeding is complete, and painting is scheduled to occur within the next 3 weeks. The project will culminate with the SRIA Morgan Park Planting Event on February 19.
- <u>Beach Ball Water Tower</u> This project includes repair and repainting of the beach ball water tower. The project is already out to bid. A pre-solicitation meeting is scheduled for 1/26, and the bid opening is 2/2/22.
- Pensacola Beach Park Rehabilitation Project (Park West and Casino Beach) This project includes: pavilion roof replacements for Park West. The project is already out to bid. A presolicitation meeting was held on 1/19 with a site walk-through scheduled for 1/27. The bid opening is scheduled for 2/1/22.
- Pensacola Beach Sign Bid solicitation is currently being prepared.

SUBJECT: Tourist Development Tax (TDT) Collections



RECOMMENDATION:

That the Board accepts, for filing with the Board's Minutes, the Tourist Development Tax (TDT) Collections Data for the November 2021 returns received in the month of December 2021, as prepared by the Finance Department of the Clerk and Comptroller's Office. This is the Third month of collections for the fiscal year 2022.

- Total collections for November 2021 were \$1,016,891; this is a 69% increase over the November 2020 return; however, the November 2021 return was remitted at the five percent rate compared to the four percent rate in November 2020.
- A four percent comparison of November 2021 to November 2020 is a 35% increase.
- Total collections year-to-date are \$1,620,162 more than the comparable time frame in Fiscal Year 2020.
- Due to COVID-19, a prior year comparison does not provide the best benchmark; therefore, analyzing the percent change between 2022 and 2020 helps provide a key metric.
- When analyzing November 2021 to November 2019 returns, Escambia County experienced growth of 92% and year-to-date collections are 84% higher than the comparable time frame in Fiscal Year 2020; however, the November 2021 return was remitted at the five percent rate compared to the four percent rate in November 2019
- A four percent comparison of November 2021 to November 2019 is a 84% increase with year-to-date collections being 47% higher.

Five Percent Tourist Development Tax Collection Data By Geographic Area Escambia County, Florida Fiscal Year 2022 As of December 31, 2021

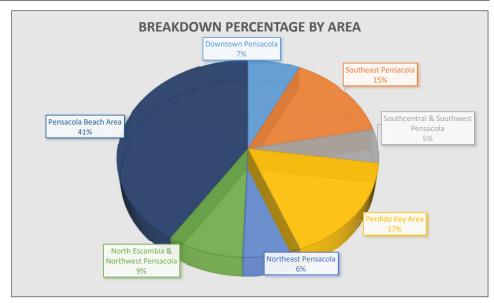
